Items included with the puppy: Puppy permanent registration application, Puppy Folder, Health Examination form, Shot record, Microchip information, starter food.

Terms:

• Payment in full must be made prior to buyer taking possession of puppy. All payments made prior to possession must clear our bank prior to puppy being released to buyer.

Health Guarantee:

• Buyer must take puppy to their veterinarian for a Well Health Exam, at the buyer's expense, within 72 hours of purchase. If in the opinion of the buyer's veterinarian, there is a problem with the puppy at this time, that is or could be life threatening, the buyer will obtain, and furnish the seller with the original Veterinarian's letter explaining the diagnosis, as well as the prognosis. If this is the case, seller will give the buyer another puppy of equal value. If seller has no puppies available at this time, seller will give buyer another puppy as soon as one comes available. The puppy that the buyer purchased must be returned to seller immediately, or an autopsy report stating the cause of death to be the fault of the seller. The seller is not responsible for any shipping charges. Seller reserves the right to have the puppy re-examined by their veterinarian at their cost. Any condition that is minor, correctable, or a breed related minor condition is not covered and no condition which could go away, or is considered to be a condition of which the puppy could grow out of is not covered. Heat stroke, exhaustion, dehydration and other heat related conditions are not covered in any way. Remember that a puppy can overheat quickly and easily and may die as a result of overheating. The seller makes no warranty as to size, eye color, coat color or breeding ability of puppy when full grown.

No warranty is given to the buyer for any special purpose or function of this puppy. The seller does not warrant puppy to be free of common problems, such as diarrhea (normally caused by changing homes or food; stress), separation anxiety, coccidiosis, or parasites. The seller can not be held responsible for veterinarian bills once puppy is placed into buyer's care. Seller does not take responsibility for contagious diseases diagnosed after 72 hours from date of purchase. The death, injury, or loss of said puppy due to theft, carelessness, recklessness, abuse, neglect, heat stroke, or accident will not entitle the buyer to any compensation from seller. Buyer's failure to have puppy examined by a licensed veterinarian within the 72 hour period voids this warranty.

The Buyer's Responsibility:

• The buyer agrees to take good care of this puppy. The buyer agrees to provide adequate food, water and housing for this puppy. Buyer agrees to control the puppy on a harness or leash when in public and when off premises of puppy's home. Acceptable provisions will be made to assure the puppy is safe anytime he/she is outdoors. Buyer agrees to give the puppy proper physical and emotional care, provide basic training, and socialize the puppy. If at any time the puppy is found to be allowed to run freely, at large, creating a public nuisance, or found to be abused, neglected, or allowed to live in poor health conditions the seller has all rights to repossession of this puppy with no refund to the buyer.

Vaccinations:

• Your puppy has been started on vaccinations. It is the buyer's responsibility to keep all vaccination and preventative medicines up to date on puppy, and to not expose puppy to any contagious or harmful diseases that may cause illness or death.

A Forever Home- First Right to Refusal:

• In the event the buyer is unable to keep this puppy for any reason, the buyer agrees to offer the seller the first chance to take this puppy back. Buyer agrees that under no circumstances is this puppy to be sold to a laboratory, pet store, research facility, or surrendered to an animal shelter, pound, or offered for free to any private individual through an ad placed in a newspaper, magazine, or other form of advertising.

Any changes to this 3-page contract must be documented and signed by both parties. This contract is a legal binding contract and may be enforced by legal means at the buyer's expense, and all disputes must be settled in Cherokee County, SC. The parties acknowledge that they have read, understood and agree to this contract in full by signing below.

Confidentiality of dispute. Seller and buyer agree, that in the event of a dispute between them, neither will publish or communicate the existence or content of such dispute in any media forum, including social media, provided that this provision shall not prevent either party from bringing legal action or engaging in confidential mediation.
