## 1. Stud Fee:

## 2. Type of Service Provided:

- If semen is shipped, stud owner agrees to send on time and with proper handling; stud fee must be paid in full prior to shipment.

- All reasonable efforts will be made to ensure a successful tie or insemination.

4. Health and Condition Requirements:

- The dam must be in excellent health, free from communicable diseases, up-to-date on all vaccinations, and cleared of internal and external parasites.

- Documentation of recent negative brucellosis test may be required prior to natural breeding.

# 5. Pregnancy Guarantee:

- This contract guarantees one confirmed pregnancy resulting in at least three (3) live puppies at birth.

- If the dam fails to conceive or whelps fewer than 3 live puppies, one free return breeding will be provided on her next heat (within 12 months).

- Veterinary proof of failure to conceive must be provided within 65 days of breeding.
- No cash refunds will be issued under any circumstances.
- 6. Neglect or Mismanagement Clause:

- If it is determined that puppy death or pregnancy failure occurred due to the neglect, poor care, or mismanagement by the dam owner, the full stud fee will become immediately due and payable, regardless of prior agreement or results.

- Neglect includes, but is not limited to: failure to seek veterinary care, unsafe housing conditions, improper feeding, or intentional harm.

- 7. Litter and Puppy Registration:
  - Both parties agree to sign and complete all necessary registration paperwork for the resulting litter.
  - Registration must be submitted within a reasonable time after birth, and the stud owner shall be properly credited.
- 8. Pick of the Litter Clause (if applicable):

- If "Pick of the Litter" is chosen as the fee, the stud owner must receive first pick before any pups are promised or sold.

- If the pick is not honored, the full monetary stud fee is due immediately.

## 9. Liability and Risk:

- S&K Prodigy Bullies LLC is not liable for complications arising during breeding, pregnancy, or whelping.
- The dam owner assumes all risks associated with ownership, veterinary care, delivery, and rearing of puppies.

## 10. Dam Owner Responsibilities:

- The dam owner agrees to:
- Provide a clean, safe, and loving environment.
- Monitor the dam during pregnancy.
- Seek immediate veterinary care if complications arise.
- Not sell, trade, or relinquish the puppies to pet stores, mills, or unethical breeders.

## 11. Legal and Binding Agreement:

- This contract is binding upon both parties. Any disputes will be settled under the laws of the state of \_\_\_\_\_
- Modifications must be in writing and signed by both parties.
- 12. Disagreements and Dispute Resolution:

- In the event of a disagreement between parties regarding the terms of this contract, both parties agree to first attempt a resolution through direct communication in good faith.

- If no resolution is reached, mediation or arbitration may be sought before taking legal action.

- Any legal disputes will be governed by and interpreted under the laws of the state of \_\_\_\_\_

- All legal proceedings shall take place in the county of the stud owner's residence unless otherwise agreed upon in writing.

- The prevailing party in any legal action will be entitled to recover reasonable attorney's fees and costs.

13. Social Media and Public Conduct:

- The dam owner agrees not to post defamatory, misleading, or negative content about S&K Prodigy Bullies LLC, its representatives, or dogs involved in this contract on any public or private platforms.

- Constructive concerns or disagreements must be addressed privately and respectfully.

- Public slander, libel, or social media attacks may result in legal action for defamation of character, breach of contract, and damages to reputation and business.

- Both parties agree to maintain a respectful and professional relationship, online and offline.
